EUTOPIA was established in 2016 with the mission to facilitate and support its members (be they natural or legal persons) to identify, investigate and seize the many opportunities (educational, work, business, financial, etc.) promoted by the European Commission.

Our vision of the future is a new and better way of being citizens, workers, and especially human beings, built over time with the will and efforts of all the people who inhabits this land we call Europe. If we walk in the same direction, it is very likely that we will all meet there.

Although we have a non-geographical discrimination policy (i.e. we are open to accept as Members individuals and legal entities from all across Europe), EUTOPIA as a local scope, which is to bring Europe in our local communities, within Marche Region. For this reason, many of the activities are currently being implemented where most Members and Associates live, i.e. in Marche (Italy).

EUTOPIA's main fields of expertise are determined by its Members and Associates' experiences and passions. In particular, as an NGO, EUTOPIA offers:

- Intercultural Exchange and Mobility support for youngsters and professionals;
- Entrepreneurship and Social entrepreneurship education for Enterprises and Individuals;





- Business support for Legal entities (Public, Profit and No-profit);
- Project Management;
- Event Management;
- Fundraising for other NGOs;
- Non-formal education.

EUTOPIA's strength is in the passion and in the competence of its Members and Volunteers.

Thanks to their dedication, since its start (in September 2016), EUTOPIA has already carried out different activities, such as:

- Managing and hosting an event in San Benedetto del Tronto, named "Restiamoinsieme!" (literally: Let's stay together), aimed at raising funds and raising awareness to support the work of the local group of volunteers from "Save the Children ONLUS" in the areas of Central Italy where the Earthquake stroke.
- Helping wannabe Entrepreneurs and Start-ups move the first steps in developing their business idea and raising funds with private equity, and National and European dedicated programmes.
- Helping youngsters, especially ones with fewer opportunities due to cultural differences (i.e. immigrants, "new italians", etc.) to develop Italian and European Citizenship and mentality through the active participation to Activities and Exchange Programmes (such as Youth Exchanges, Training Courses, EVS).
- Delivering non-formal trainings at local level on "Idea development" and "Design Thinking" techniques, to foster new product/service ideas as well as project ideas, such as EUTOPIALAB (www.associazioneeutopia.org/eutopialab).
- Focusing on how to tackle different types of violence, and learning from our partners many different points of view and practices on the various forms violence can take (domestic violence, economic violence, social violence, bullying, religious violence, etc.), thanks to our KA2 Project "Violence, Important Problem" (2017-1-PL1-K204-038300). Moreover, in the project we're in charge of analysing, presenting, sharing and disseminating practices to recognize and fight on-line and off-line hate speech, in particular against migrants and vulnerable groups. Moreover, EUTOPIA is also very active in promoting the human rights and the involvement in decision-making of "New Italians", i.e. second generation migrants. We strongly believe that they brought to the Country new perspectives and strength and we fight daily against the odious and continuous hate speech, fostered by a consistent part of Political organizations on the Mass Media and Social Networks, against the many Italian residents of Eastern-European origins. This is a form of violence we do not tolerate, especially now that it has exploded nation-wide due to the facts happened in our Region (Macerata).

EUTOPIA, as member of "Bottega del TerzoSettore", a second-level Association based in Ascoli Piceno aimed at uniting all NoprofitOrganisations at Province Level, was actively involved with its President (Mr. Ameli) in the Work Groups for the design of 2018-2020 strategy for Innovation and Fundraising.

EUTOPIA is also the Coordination Point for Marche Region of the NO HATE SPEECH MOVEMENT, a campaign promoted by the Council of Europe.
